STATEMENT OF UPSTANDER ACTION

Attach your personal Statement of Upstander Action. Provide a narrative (limited to two pages, 12-point font, double spaced) that describes your action(s) as an upstander. Suggested prompts may include:

Describe how were you inspired to take action as an upstander.

Explain in detail your achievement(s) to combat intolerance, prejudice and injustice.

What was the hope and/or expectation for your action?

Explain how your action(s) incorporates the values of C.A.R.E. - compassion, acceptance, respect and/or empathy.

Showcase how your efforts created positive change in your school, club, and/or community. What was the measurable impact(s) of your action(s)? Were there any intangible outcomes?

Was this a one-time action or an ongoing project? Do you have plans to continue it?

Describe any challenges you met. How did you overcome them?

How did courage, tenacity and leadership play a role in your act(s)?

Who or what has encouraged you to become an activist for human rights?

Have you been nominated or awarded recognition for this work by another organization?

Provide other pertinent information - number of people involved, uniqueness of action/project, goals met or exceeded, etc.

LETTERS OF RECOMMENDATION

Attach two letters of reference. The letters of recommendation should be from a teacher/advisor/sponsor or another person who can speak in detail about the upstander actions. List valid contact information for the recommenders. This is an opportunity for them to commend and support a young person for standing up to hatred, prejudice and intolerance. Suggested prompts or recommendations may include:

- How do you know the upstander nominee? Provide contextual information.*
- Explain why you think this nominee should be granted this award.*
- Describe the nominee’s unique action(s) and how he/she supported the ideals of C.A.R.E. - compassion, acceptance, respect and/or empathy.*
- Summarize the strengths of the nominee.*
- Provide any other pertinent information.*
